

## **CAMP RULES AND REGULATIONS**

The Children's Advocacy Center Foundation and Camp Thrive Las Vegas have set forth these camp rules and regulations for the safety of all campers.

- 1. Campers are prohibited from bringing dangerous weapons to the camp site including but not limited to: (a) any explosive or incendiary devices; (b) a dirk, dagger, or switchblade knife; (c.) a nunchaku or trefoil; (d) a blackjack, billy club or metal knuckles; (e) a pistol, revolver or other firearm (including pellet or BB guns); and (f) any device used to mark any part of a person with paint or any other substance (e.g., paintball guns). The use, or possession, of any dangerous weapons is expressly prohibited at camp.
- 2. The serving or consumption of any alcoholic beverages is expressly prohibited at camp. Any camper who appears to be intoxicated at any given time during camp will be asked to leave immediately.
- 3. The use or possession of tobacco and marijuana products (including for medical purposes), alternative nicotine products and vape products is expressly prohibited at camp. Any camper using, or in possession of these products, will be asked to leave immediately.
- 4. The use or possession of illegal substances is expressly prohibited at camp. Any camper who appears to be under the influence, or in possession of, illegal substances will be asked to leave immediately.
- 5. Any photograph or video taken at camp to use in personal and/or promotional materials, including but not limited to social media sites, is expressly prohibited at camp.
- 6. Any cell phone or electronic devices brought to camp will be kept with camp staff to prevent loss or theft. Phone usage during camp will be permitted during scheduled "check-in" calls and camp staff will monitor all campers to ensure that outgoing phone calls are being made to parent/legal guardian or emergency contacts. It is highly encouraged that cell phones and electronic devices are left at home.
- 7. Campers assume all risk of loss or damage to personal property or clothing please refrain from bringing expensive valuables to camp.
- 8. Any property of any kind owned, including but not limited to cabins, common areas, landscaping, animals on premises, etc., by 4-H Camp Alamo, Children's Advocacy Center Foundation, Camp Thrive Las Vegas, shall not be tampered with, removed or intentionally damaged.
- 9. Any behavior such as pranks, inappropriate touching/comments, engaging in intimate/sexual relationships, sneaking out at night, rough housing, hurting others' feelings, destroying camp property, etc., is expressly prohibited at camp.
- 10. All campers have an expectation of respectful communication with all individuals regardless of the individual's level of ability, culture, race, gender, religion, sexual orientation, or gender identity.
- 11. Dorms/rooms are off-limits to members of the opposite sex. Failure to comply may result in all persons involved being sent home at parents' expense.
- 12. No food is to be kept in the dorms/rooms and no food is to be removed from the dining hall



- 13. All campers must participate in scheduled activities as laid out in the Camp Agenda. If a camper refuses to participate in said activities, and voluntarily chooses to go home, parent/legal guardian or emergency contacts will be notified and asked to drive up to camp to pick up their child.
- 14. If any camper becomes ill or injured during camp, camper will be medically attended to by camp nurse and parent/legal guardian or emergency contact will be notified. If the illness or injury is too severe for the camper to remain for the duration of camp, parent/legal guardian or emergency contact must pick up the child from camp.

## **CAMP WAIVER AND AGREEMENT**

## Camp Waiver and Agreement must be signed by all parties (camper and parent/legal guardian)

In consideration of the acceptance of my application I, the undersigned, for myself, my heirs, executors and administrators, hereby waive, release and discharge any and all rights and claims for damages I may have or which hereafter accrue to me against the persons and organizations affiliated with the Children's Advocacy Center Foundation, Camp Thrive Las Vegas or the 4-H Camp and Learning Center and their representatives, successors, and assignees for all injuries suffered by me while traveling to and from or in any way associated with my participation in Camp Thrive Las Vegas summer camp.

I have read all of these rules and regulations, and have discussed them with my parent(s)/legal guardian(s), and will obey them while a camper at Camp Thrive Las Vegas. I understand that failure to comply with these policies may result in immediate removal from camp. My parent/legal guardian will assume the responsibility and expense to pick me up from camp should I be found in violation of camp rules and regulations.

Prior to submitting this Camp Rules and Regulations Form, I have read and understood all portions of this form. Any questions I may have had about the rules and regulations of Camp Thrive Las Vegas have been answered to my satisfaction.
